



Family reunion

1. General Information

Please note that your visa application must be made in person and will be accepted only if all required documents are sorted and submitted according to our regulations.

Appointments can be booked online free of charge: www.tallinn.diplo.de/Terminvergabe

2. Fees

No fee is charged for processing visas for reunion with German citizens or citizens of EU states using their right to move and reside freely. The fee for processing applications for family reunion visas to spouse holding passports of other countries is 75 EUR for adults and 37,50 EUR for minors. This amount has to be paid in cash or per credit card. This is a processing fee. Thus, a refund in case of withdrawal of application or upon denial is not applicable.

3. Process

The applications are forwarded to the alien authority in Germany for an advisory statement. Therefore processing a family reunion visa usually takes several weeks and may be extended to several months. As soon as a decision has been made, the applicant is immediately contacted by the embassy.

In order to avoid unnecessary delays, applicants are kindly asked not to make any inquiries about the current status of their applications.

4. Required documents

Please make sure that you provide a complete application form and all documents required. Incomplete applications will not be considered. Each submitted documents in original has to be accompanied by 2 copies. Documents in foreign language have to be provided with a certified translation into German or English.

REUNION TO SPOUSE OR CIVIL PARTNER

- 2 application forms (and declaration in accordance with section 54 (2) No. 8 i.V.m. § 53 of the Residence Act) <https://videx-national.diplo.de/videx/visum-erfassung/#/videx-langfristiger-aufenthalt>
- 2 recent identical passport photos (45x35 mm)
- your national passport (validity has to exceed at least 6 months; issued not earlier than 10 years ago), original + 2 copies of **all pages with records**
- Estonian residence permit (e.g. visa / residence card), held for at least 3 months at the time of application, original + 2 copies
- current resident registration certificate from Estonian population register (2 copies)
- marriage certificate or civil partnership agreement with an apostille* (preferably an international certificate, if applicable notarized translation into German or English), original + 2 copies

*An apostille is only required for those documents that have **not** been issued in an EU or EEA country.

- if applicable: in case of former marriages and divorces a legally signed German divorce decree or an approval of the foreign divorce decree issued by a German court, original + 2 copies

- certificate for German language skills meeting the level A1 (not applicable if the partner in Germany is a citizen of a EU/EEA state, holder of EU Blue Card, but applicable for reunions with German citizens), original + 2 copies

The certificate has to be issued by a certified operator of these who has a branch operated by dispatched staff members in accordance to the ALTE standards (Association of Language Testers in Europe).

- Health insurance valid in Germany, 2 copies
- Passport or ID card of the spouse living in Germany; in case the spouse is not a German citizen, his/her residence permit must be provided as well, 2 copies;
- Current extended registration certificate (erweiterte Meldebescheinigung) of the spouse/registered partner in Germany with information about his/her marital status. The certificate may not be older than 6 months;
- Salary statements of the spouse of the last 3 months
- Proof of sufficient living space

REUNION OF A CHILD TO A PARENT

- 2 application forms (and declaration in accordance with section 54 (2) No. 8 i.V.m. § 53 of the Residence Act) <https://videx-national.diplo.de/videx/visum-erfassung/#/videx-langfristiger-aufenthalt>
- 2 recent biometric passport photos (45x35 mm)
- Child's national passport (validity has to exceed at least 6 months; issued not earlier than 10 years ago), original + 2 copies of **all pages with records**
- Estonian residency permit (e.g. visa / residence card), held for at least 3 months at the time of application, original + 2 copies
- Birth certificate with an apostille* (if applicable international recognition of the certificate, translation into German or English), original + 2 copies
*An apostille is only required for those documents that have **not** been issued in an EU or EEA country.
- If applicable, marriage certificate of the parents, acknowledgment of paternity certificate or degree with an apostille* (if applicable recognition of the certificate, translation into German or English), original + 2 copies
*An apostille is only required for those documents that have **not** been issued in an EU or EEA country.
- If applicable, certificate of adoption or degree with an apostille* (if applicable recognition of the certificate, translation into German or English), original + 2 copies
*An apostille is only required for those documents that have **not** been issued in an EU or EEA country.

- Passport or ID card of the parent living in Germany (2 copies); in case the reference person is not a German citizen, his/her resident permit;
With regard to citizens of EU/EEA states using the right to move and reside freely: passport or ID card issued by the respective member state (2 copies)
- Proofs concerning income and living space (rental agreement) of the parent living in Germany, 2 copies
- Resident registration card/document of the parent living in Germany, 2 copies
- Health insurance valid in Germany, 2 copies

And if applicable:

- Divorce decree of the child's parents (if applicable international recognition of the certificate, translation into German or English), original + 2 copies

- Custody decree stating that the sole custody lies with the respective parent or a notary certified consent of the second parent for the child to leave the country on a permanent basis (if applicable international recognition of the certificate, translation into German or English), original + 2 copies

**In individual cases it may be necessary to provide additional documents.
